- Grant Summary: The Idaho Farmers Market Association is offering funding to help Idaho farmers markets retain, recruit, and promote specialty crop vendors and highlight community involvement through small scale funding opportunities around specialty food crops.
- Grant Description: Funds will allow farmers markets the flexibility to choose their own methods of advertising and promotion of specialty crops and vendors. The goal is to increase sales, education, and consumption of these products sold at Idaho Farmers Markets.
- Funding Amount: this second round of mini-grants will reimburse \$450 per market for expenses between March 4, 2024 and May 31, 2024.
- We will have a third and final round available from June 1, 2024, to August 31, 2024.
- Funding is limited, so the first 10 successful applications will be funded each round.
- For faster reimbursement submission of receipts is required.
- Incomplete or late applications will not be accepted.
